7. Life Standards:

As a Short Term Missions Team Member, I will to be punctual and submit to the rules set forth by First Assembly of God. It is impressed upon every team member the urgency of Salvation, the Holy Spirit, the importance of study, and the necessity of self-discipline.

- 1. You are NOT to participate if you live with a person as if you are married to them when you are not, even if no "sin" is being committed (1 Thess. 5:22).
- 2. You are NOT to participate, if you have not gained victory in manifestation over smoking, drinking, narcotics of any type, immoral sexual habits, and spouse or child abuse.
- 3. Your dress code should be such that it is not a distraction from your ministering the Word; such as ladies wearing low cut blouses, tight fitted tops and bottoms or attire that would give too much exposure. You should be well groomed at all times including keeping a mouth/breath freshener on your person. If you are going to have a beard or mustache, it should be well trimmed at all times.
- 4. If it is noticed that you exhibit unstable emotional traits according to the judgment of the leaders in charge, we have the right to refuse your request to remain in the ministry.
